This application must be submitted for any modifications or alterations to the interior of screened porches, patios, and any other portions of lot structure visible from outside a structure. The application MUST BE ACCOMPANIED BY THE FOLLOWING: 1) **SKETCH** INDICATING LOCATION, SIZE AND TYPE OF CONSTRUCTION 2) A COPY **OF** YOUR **SURVEY SHOWING WHERE THE CHANGES WILL BE LOCATED**, AND OTHER PERTINENT INFORMATION AND 3) ALSO ATTACH A COPY OF YOUR CONTRACTOR'S LICENSE, INSURANCE CERTIFICATE (LIABILITY & WORKMAN'S COMPENSATION **CERTIFICATE**)

If approval is granted, it is not to be construed to cover approval required by any governmental agency. A **building** permit from the St. Lucie County Building Department is **needed** on most property alterations or improvements. **NOTE: Any alterations may not encroach onto any existing easements**.

As a condition precedent to granting approval of any request for a change, alteration or addition, the applicant, the heirs, and assigns thereto, hereby assume sole responsibility for the repair, maintenance or replacement of any such change, alteration or addition. It is understood and agreed that the **ASSOCIATION IS NOT** required to take any action to repair, replace, or maintain any such approved change, alteration, or addition, or any damage resulting there from for any reason to the existing original structure, or any other property. THE UNIT OWNER ASSUMES ALL RESPONSIBILITY AND COSTS FOR ANY ADDITION OR CHANGE, AND ITS FUTURE UPKEEP **PLUS** ANY WORK THAT HAS TO BE DONE ON THE COMMON GROUNDS THAT IS AN ADDED EXPENSE BECAUSE OF THIS ADDITION OR CHANGE.

<u>NOTE</u>: FENCE INSTALLATIONS WILL REQUIRE THE HOMEOWNER TO MAINTAIN THE FENCE AND LANDSCAPING AROUND THE FENCE AS WELL AS INSIDE THE FENCE AREA. THIS MAINTENANCE MUST BE DONE BY THE HOMEOWNER AT NO EXPENSE TO THE ASSOCIATION.
